After School /Summer Care: Student Enrichment Program Tuition Charges

After-school care is offered for the entire 2012-2013 school year session for grades K-6. We offer two options:

- Full-Time Care: \$250.00 per month
- Drop-in Care: \$25 per day. Drop-in care is dependent upon space available at time of drop-in request. Payment must be arranged individually with our SEP Manager.

Full-time Summer care is offered for June, July and August from 7:30 am to 6:00 pm, M-F. (\$1,000 for all three months)
